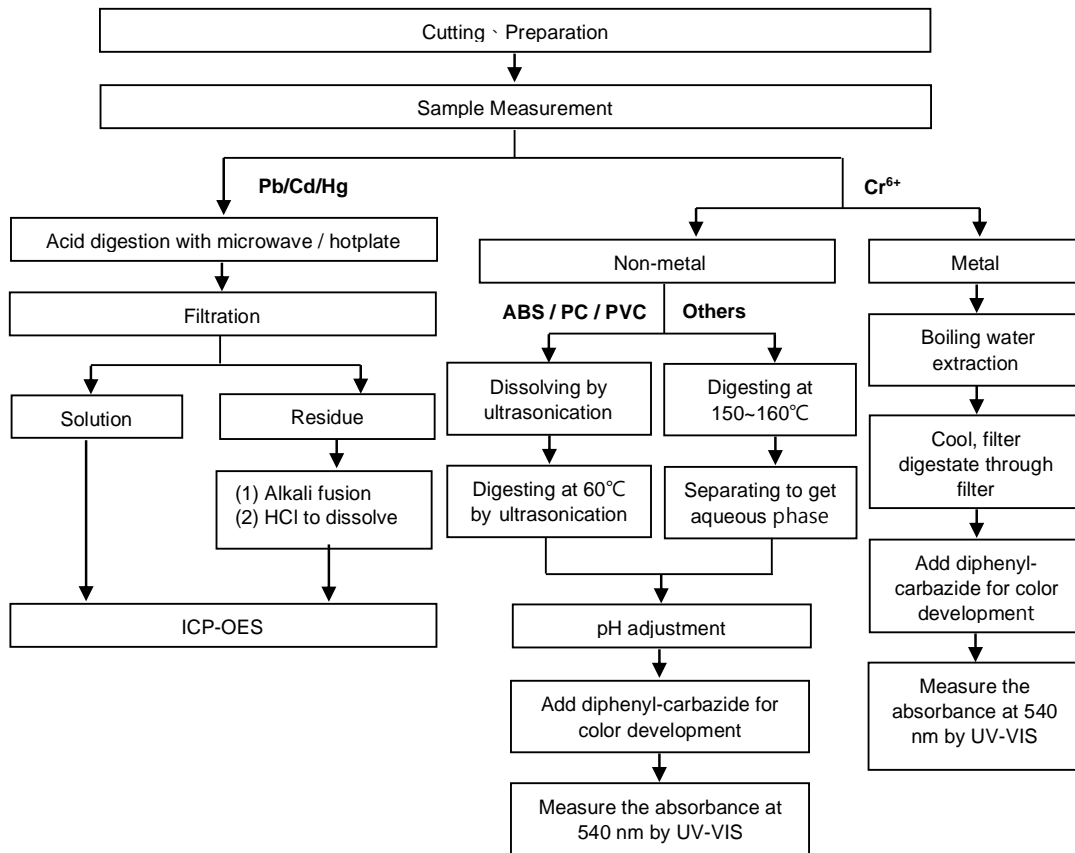

Analytical flow chart of Heavy Metal

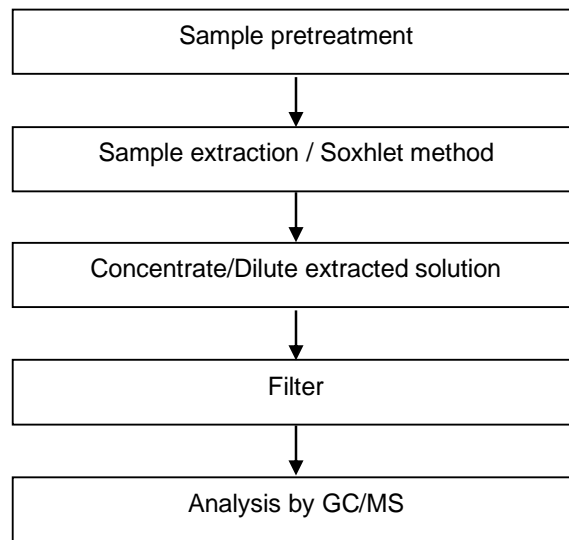
These samples were dissolved totally by pre-conditioning method according to below flow chart. (Cr⁶⁺ test method excluded)

PBB/PBDE analytical FLOW CHART

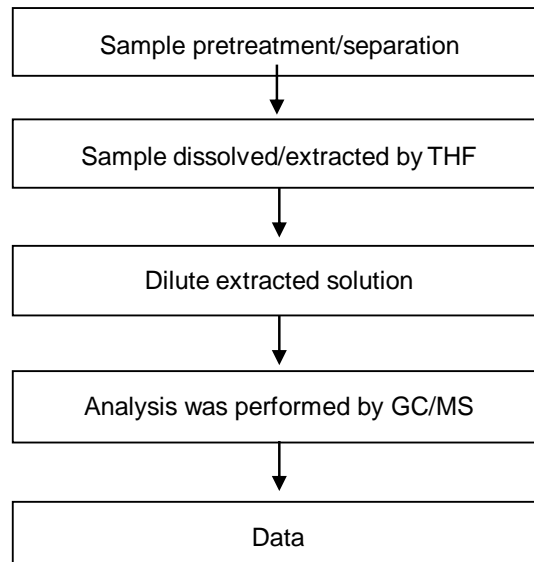
