TPSC ASIA PTE LTD state that we only use qualified component manufacturers in our products, whose specifications meet or exceed the requirements of the European Directive for the Restriction of use of certain Hazardous Substances (RoHS) that were introduced in July 2006, and also include the recast requirements laid down in Directive 2011/65/EC (the EU RoHS 2 directive) and amendment Directive (EU) 2015/863. We hereby certify that our products do not contain any of the following banned substances, in quantities which would exceed those specified limits (excluding components used that are approved via RoHS exemption for certain materials and applications):

- Lead (Pb) - Limit: 0.10% of component weight ($\leq 1000\text{ppm}$)
- Mercury (Hg) - Limit: 0.10% of component weight ($\leq 1000\text{ppm}$)
- Cadmium (Cd) - Limit: 0.01% of component weight ($\leq 100\text{ppm}$)
- Hexavalent Chromium (Cr6+) - Limit: 0.10% of component weight ($\leq 1000\text{ppm}$)
- Polybrominated Biphenyls (PBBs) - Limit: 0.10% of component weight ($\leq 1000\text{ppm}$)
- Polybrominated Diphenyl Ethers (PBDEs) - Limit: 0.10% of component weight ($\leq 1000\text{ppm}$)
- Bis(2-Ethylhexyl) phthalate (DEHP) - Limit: 0.10% of component weight ($\leq 1000\text{ppm}$)
- Benzyl butyl phthalate (BBP)- Limit: 0.10% of component weight ($\leq 1000\text{ppm}$)
- Dibutyl phthalate (DBP) - Limit: 0.10% of component weight ($\leq 1000\text{ppm}$)
- Diisobutyl phthalate (DIBP) - Limit: 0.10% of component weight ($\leq 1000\text{ppm}$)

Additionally, we do not add the following substances to our products:

- Tetrabromobisphenol A (TBBP-A)
- Medium chain Chlorinated Paraffin (MCCP)
